Clubhouse Access Membership allows the applicant to utilize the facilities **January 1st until December 31st**. The applicant's signature on the membership contract indicates agreement to comply with the terms and conditions as set out in the Membership Terms & Conditions.

MontHill Golf and Country Club reserves the right to cancel a membership for conduct unbecoming as a member of the course, non-adherence to Terms & Conditions

## RULES & REGULATIONS

By filling out this form you are agreeing to follow the rules and regulations of MontHill GCC

### 1. Dress code

We ask that golfers be properly attired at all times on the premises and in the clubhouse. Shirts with collars and sleeves are preferred and must be worn at all times. Mesh or muscle shirts and any attire with offensive writing are not acceptable. For ladies, halter or tube tops are not acceptable. Shorts with 5-inch inseam are acceptable. Gym shorts, cut offs, track or sweatpants are not acceptable. You will be asked to change or leave. Our pro shop will be fully stocked with appropriate apparel available for purchase at our convenience.

### 2. Etiquette

Members are asked to fix ball markers, replace divots, rake bunkers and dispose of litter in the appropriate containers. MontHill would like to keep the course and facility clean and presentable for our members and their guests and we need your help keeping it that way. We ask Members to play in groups of 4 golfers or less. Always be courteous to fellow golfers and let faster players play through. MontHill prides itself on its principles and standards for customer service. We ask members to interact with MontHill staff in a positive way, both on the course and in our clubhouse so we can maintain a positive space for all patrons and staff. If you have an issue with a staff member or are made aware of an incident, please report it to Management at your earliest convenience and we will see that it is handled properly.

### 3. Golf Course Property Damage

In the event that the member damages the course, carts, or facility they will be responsible for the repairs of that damage. The damage will be assigned directly to your credit card left on file. Also, due to the nature of the damage they could have their membership suspended or even revoked.

### 4. Alcohol

MontHill Golf & Country Club is a licensed establishment and personal alcohol is not permitted on the premises. This includes the golf course, clubhouse, and parking lot. This is a serious matter as MontHill could lose their liquor license by having unlicensed alcohol consumed on the premises. If you are caught with your own alcohol, it will be taken away immediately, and you will be given a verbal warning. If you are caught a second time your membership will be suspended until you meet with course management. If it happens a third time, your membership will be terminated without a refund.

### 5. Rules of Play

All members and their guests must check in with the Proshop, or starter prior to their tee time. Players must wait for their tee time or consult with the marshal/starter before teeing off. Players must keep all power carts at least 30 feet away from tees and greens and do not go beyond the No Cart line in front of greens. Please use the cart paths where provided, and only two persons per cart. Marshalls have full authority to control pace of play and report any personal alcohol or course damage by individuals on the course.

### 6. Payment Terms & Minimum Spending

Members are required to bill a minimum of \$1000 to their member account annually. Payments on member accounts can be made by a credit card on file, credit card over the phone or in person at the Pro Shop. Payments on member accounts should be made on a monthly basis to avoid account suspension. Accounts will only be suspended when there is a past due balance of over \$1000 and have aged over 45 days. Written notices will also be sent beforehand to avoid account suspension.
